

ORDINANCE NO. 825

I. Purpose. AN ORDINANCE RECODIFYING THE SALEM CITY CODE FOR THE PURPOSE OF REVISING, AMENDING, REORGANIZING THE GENERAL ORDINANCES OF THE CITY OF SALEM, INDIANA.

II. Statutory Authority. I.C. 36-1-5-1 thru 6.

III. City Code Citation Affected. Not applicable.

IV. Legislative Findings.

a. The present City Code which was adopted by Ordinance 543 on January 6, 1986, with an effective date of February 1, 1986, has been amended numerous times since that date and is presently incomplete and inadequate in that it does not include all of the present ordinances of the City of Salem, Indiana and does not contain a complete index of the ordinances of the City of Salem, Indiana.

b. That the recodifying of the present Salem City Code and Ordinances adopted since 1986 should be undertaken pursuant to the provisions of I.C. 36-1-5-1 thru 6.

c. That the proposed recodification of the Salem City Code as prepared by American Legal Publishing Corporation which is complete through Ordinance #815 adopted on December 12, 1994.

d. That the Common Council of the City of Salem, Indiana now authorizes a general compilation, revision and recodification of the ordinances of the city in book form as prepared by American Legal Publishing Corporation.

IT IS NOW THEREFORE ORDAINED AS FOLLOWS:

V. Ordinance.

Section 1. The general ordinances of the City of Salem as herein revised, amended, restated, codified, and compiled in book form are adopted as and shall constitute the "Code of Ordinances" of the City of Salem, Indiana.

Section 2. Said Code as adopted in Section 1 shall consist of the following titles, to-wit:

Section 3. All prior ordinances pertaining to the subjects treated in said Code shall be deemed repealed from and after the effective date of said Code except as they are included and reordained in whole or in part in said code; provided such repeal shall not affect any offense committed or penalty incurred or any right established prior to the effective date of said Code, nor shall such repeal affect the provisions of ordinances levying taxes, appropriated money, annexing or detaching territory, establishing franchises or granting special rights to certain persons, authorizing public improvements, authorizing the issuance of bonds or borrowing of money, authorizing the purchase or sale of real or personal property, granting or accepting easements, plat or dedication of land to public use, naming or vacating or setting the boundaries of streets, alleys or other public places, nor to any other ordinance of a temporary or special nature or pertaining to subjects not contained therein.

Section 4. Said Code shall be deemed published as of the day of its adoption and approval by the Common Council of the City of Salem, Indiana and the Clerk-Treasurer of the City of Salem, Indiana is hereby authorized and ordered to file a copy of said Code in the Office of the City Clerk-Treasurer.

Section 5. Said Code shall be in full force and effective upon adoption and filing thereof in the Office of the Clerk-Treasurer and said Code shall be presumptive evidence in all courts and places of the ordinance and all provisions, section, penalties, and regulations therein contained and of the date of passage, and that the same is properly signed attested, recorded and approved and that any public hearing and notices thereof as required by law have been given.
